



4 Everdeck® Warranty

Decking and Railing products, when properly installed and maintained are warranted to the original purchaser for a period of 10 years (4 Everdeck® Ultra Products are guaranteed for 20 years) from date of purchase, against rot, structural decay, splitting, checking, splintering, or termite damage under normal conditions of decking use and exposure.

Each purchaser of a 4 Everdeck® Product is solely responsible for determining the effectiveness, suitability and safety of any particular use or application of the product. Building code regulations vary from area to area. Each 4 Everdeck® Purchaser should consult local building and safety codes for specific requirements in connection with the installation of a decking structure.

Limitations of Coverage

4 Everdeck® shall have no liability for defects or damage resulting from;

- (A) Installation directly on top of or attached to a concrete slab, installation directly on the ground, installation directly on top of other decking, or any installation which precludes proper ventilation above, below, and to the side.
- (B) Maximum joist spacing is 350mm centre to centre. Anything more than 350mm automatically voids the guarantee. 4 Everdeck® Deck Clips must be used at each joist regardless of joist spacing.
- (C) Lack of proper 5mm side to side gapping between deck boards for drainage, cleaning and ventilation.
- (D) Sharing of clips between boards that are butted up against each other. (Guarantee is voided if clips are shared).
- (E) Mould or mildew growth, extractive bleeding, chalking, water rings, food, organic, pet, or paint stains.
- (F) Settlement, shrinkage, or distortion of the substructure.
- (G) Decks which are not properly sloped for drainage.
- (H) Non-approved surface treatments applied to the deck.
- (I) Stains from galvanized or uncoated screws.
- (J) Use as a structural member.
- (K) Improper handling, storage, abuse or neglect by Purchaser or third party.
- (L) Variations or changes in colour of 4 Everdeck (All colours will fade a minimum of 10%. 4 Everdeck® Decking Systems, shall have no liability for the cost or removal of faded decking or railing

If for any reason you believe the decking or railing is defective, DO NOT INSTALL. Contact your dealer. 4 Everdeck® Systems will not be liable for claims arising from installation of visibly defective product.

MOULD OR MILDEW IS NOT A MANUFACTURING DEFECT AND IS NOT COVERED BY THIS WARRANTY NOR ANY IMPLIED WARRANTY.

Remedy & Notification of Claims

Suppliers liability under this Warranty is limited solely and exclusively to replacement of defective 4 Everdeck® Product, and in no event shall supplier be liable for labour, installation, reinstallation, transport or any other charge related to defective product.

Supplier shall not be liable for any indirect, incidental, punitive, consequential, exemplary or other damages of any kind whatsoever, whether any such claim is based upon theories of contract, warranty, negligence, tort, strict liability or otherwise. In any dispute over the performance of the product, the purchaser shall have the burden of proof that the product was installed, finished and maintained in accordance with the supplier's applicable instructions.
